No. 4333 in the name of Biman Behari Paul, 4334 in the name of Basanta Behari Pal, 2812 in the name of Dipti Rekha Pal, 3245 in the name of Partha Sarathi Paul, copy of C.S. Record of Rights bearing C.S.R.O.R. No. 328 in the name of Baishnab Charan Das, copy of Government Rent Receipt bearing Receipt No. 4658176 dated 25/05/2018 in the name of Biman Behari Paul, 4658177 dated 25/05/2018 in the name of Basanta Behari Pal, 4658178 dated 25/05/2018 in the name of Partha Sarathi Paul and 4658179 dated 25/05/2018 in the name of Dipti Rekha Pal, copy of Municipal Tax Receipt bearing Receipt No. A/0000486 dated 03/04/2018 of English Bazar Municipality in the name of Bhubaneswar Paul, Legal Heirs Affidavit dated 22/11/2017 sworn by Ritankar Pal and thirty years carefully searched made by me in the Sadar Registry Office.

It appears from the above documents, that the property mentioned below previously belonged to Baishnab Charan Das and C.S. Record of Rights duly been prepared in his name bearing C.S.R.O.R. No. 328.

Subsequently Lilabati Paul died leaving her three sons namely Biman Behari Paul, Partha Sarathi Paul, Basanta Behari Pal and only daughter namely Dipti Rekha Pal as her legal heirs and Basanta Behari Pal one of the son of Bhubaneswar Paul died leaving his wife namely Bharati Pal and only son namely Ritankar Pal as his legal heirs and they inherited the property left by Basanta Behari Pal and Ritankar Pal sworn an Affidavit to that effect on 22/11/2017.
