LTD. having PAN AAECP0892J, a company incorporated under the Companies Act, 1956 having its registered office at Premises No.2C, Mahendra Road, Post Office-Bhowanipore, Police Station-Bhowanipore, Kolkata-700 025, represented by Mr. Chandan Chatterjee, son of the Late S.K. Chatterjee, having PAN ACRPC0270H, and Mr. Amit Bajoria, son of Srikrishna Bajoria, having PAN AHCPB2460Q, both of 2C, Mahendra Road, Police

Station-Bhowanipore, Kolkata-700 025, the Authorized Signatories duly authorized by the Resolutions of the respective Board of Directors of the companies dated 24.04.2017, hereinafter jointly referred to as the **PURCHASERS** (which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include their respective successors or successors-in-interest and assigns) of the **THIRD PART**:

WHEREAS:

- A) One Robert Dalglish was seized and possessed of and or otherwise well and sufficiently entitled to All that the piece and parcel of land containing an area of 18 cottahs and 7 chittacks be the same a little more or less situate lying at Mouza Naktala, Police Station Tollygunge, Touzi No.66, C.S. Khatian Nos.79 and 80, C.S. Dag Nos.122/508 and 178, in the District of the then 24-Parganas (hereinafter referred to as the said Land).

"Santilal Manilal HUF" comprised of Santilal Manilal and his four sons, namely, (i) Narendra Shantilal; (ii) Rajendra Shantilal; (iii) Yashwant Shantilal; and (iv) Bepin Shantilal and Pradip Narendra, a minor son of the said Narendra Shantilal.
- O) "Shantilal Manilal HUF" decided to sell the said Land to the family partnership business namely Naktala Iron Works.

Sardaben Shah and Narendra Shantilal therein referred to as the Purchaser of the other part and registered at the office of the Sub-Registrar Alipore Sadar, in Book No.I, Volume No.100 Pages 198 to 204 Being No.5701 for the year 1961 the said vendors jointly therein for the consideration mentioned therein granted transferred conveyed assigned and assured unto and in favour of the said purchaser therein all that the said Land.
- G) The partners of the said Naktala Iron Works had constructed and erected three temporary asbestos shed and structure and one storied brick built permanent structure on the said Land.
- H) The said Sardaben Shah retired from the partnership business on 30th October 1970.
- By an Indenture of Partnership dated the 16th Day of December 1970 made between the said Narendra Shah therein referred to as the party of the First Part, Jaswant Shah therein referred to as the Party of the Second Part, Bipin Chandra Shah therein referred to as the party of the Third Part and Nalin Shah therein referred to as the party of the Fourth Part, the said Jaswant Shah, Bipin Shah and Nalin Shah were admitted as partners to the said partnership business upon the retirement of the said Smt. Sardaben Shah.
- J) The said Land was assessed and numbered as Premises No.4 Naktala Road by the then Calcutta Municipal Corporation more fully and particularly described in the Schedule hereunder written (hereinafter referred to as the said Premises).
- K) By another Indenture of Partnership dated the 24th day of February 1981, made between the said Narendra Shah therein referred to as the party of the First Part, Jaswant Shah therein referred to as the Party of the Second Part, Bipin Chandra Shah therein referred to as the party of the Third Part, Nalin Shah therein referred to as the party of the Fourth Part, Shambhulal Manilal therein referred to as the Party of the Fifth Part and Smt. Varsha Shah therein referred to as the Party of the Sixth Part, the said partnership was reconstituted and Shambhulal

Manilal and Smt. Varsha Shah were admitted as partners to the said partnership business.

- On 28th day of October 1981 the said Shambhulal Manilal and Bipin Chandra Shah retired from the said partnership business and in consequent to that the said Narendra Shah, Jaswant Shah, Nalin Shah and Smt. Varsha Shah had jointly executed another Indenture of Partnership dated the 23rd day of January 1982 whereby and where under they had mutually agreed and reconstituted the said partnership business on the revised terms and conditions.
- M) By another Indenture of Partnership dated the 1st day of April 1989, made between the said Narendra Shah therein referred to as the party of the First Part, Jaswant Shah therein referred to as the Party of the Second Part, Nalin Shah therein referred to as the party of the Third Part, Smt. Varsha Shah therein referred to as the party of the Fourth Part, Shambhulal Manilal therein referred to as the Party of the Fifth Part and Bepin Chandra Shah therein referred to as the Party of the Sixth Part, the said partnership was reconstituted and Shambhulal Manilal and Bepin Chandra Shah were again admitted as partners to the said partnership business.
- N) The said Premises was reassessed and renumbered by the Kolkata Municipal Corporation and known as Premises No.4Q, Naktala Road, Kolkata.
- O) By an Indenture of Retirement dated the 27th day of July 1990 made between the said Narendra Shah therein referred to as the party of the First Part, Jaswant Shah therein referred to as the Party of the Second Part, Bepin Chandra Shah therein referred to as the party of the Third Part, Nalin Shah therein referred to as the party of the Fourth Part, Shambhulal Manilal therein referred to as the Party of the Fifth Part and Smt. Varsha Shah therein referred to as the Party of the Sixth Part, the said Smt. Varsha Shah retired from the said partnership business.
- P) By another Indenture of Partnership dated the 31st day of August 1991 made between the said Narendra Shah therein referred to as the party of the First Part, Jaswant Shah therein referred to as the Party of the Second Part, Nalin Shah therein referred to as the party of the Third Part, Shambhulal Manilal therein referred to as the Party of the Fourth Part, Bipin Chandra Shah therein referred to as the Party of the Fifth Part and one Kartick Shah therein referred to as the Party of the

Sixth Part, the said partnership was reconstituted and Kartick Shah was admitted as Partner to the said partnership business.

- Q) The said Shambhulal Manilal died on 13th day of August 2005 leaving him surviving his only son Nalin Shah.
- R) The said Jaswant Shah died on 1st day of March 2006 leaving him surviving his widow Smt. Jyotsna Shah and only son Ketan Shah and only daughter Smt. Sunita Pratap as his legal heiresses heir and legal representatives.
- By another Indenture of Partnership dated that 1st day of April 2013 made between the said Narendra Shah therein referred to as the party of the First Part, Nalin Shah therein referred to as the party of the Second Part, Bepin Chandra Shah therein referred to as the party of the Third Part, Kartic Shah therein referred to as the party of the Fourth Part, Ketan Shah therein referred to as the party of the Fifth Part and Smt. Jyotsna Shah therein referred to as the party of the Sixth Part, the said partnership was reconstituted and Ketan Shah and Smt. Jyotsna Shah were admitted as partners to the said partnership business.
- The Confirming Party herein has divested herself of her right title and interest in respect of her undivided part or portion of the said Premises and has agreed to confirm the sale of the said Premises unto and in favour of the Purchasers.
- U) The Vendor Naktala Iron Works represented by its present partners has agreed to sell and the Purchasers have agreed to purchase and the Confirming Party has agreed to confirm the sale of the said Premises free from all encumbrances, charges, liens, lispendense, attachments, acquisitions, requisitions and trusts of whatsoever nature at and for the consideration of Rs.3,23,00,000/- (Rupees Three Crores and Twenty Three Lacs only).
