


AFFIDAVIT

Lake Town, Kolkata-700089, do hereby solemnly affirm and say as follows :-



1. That Mohini Mohan Ghosh died leaving behind his wife Sundari Ghosh and two sons (a) Bhupesh Chandra Ghosh and (b) Paresh Chandra Ghosh, the surviving legal heirs.
2. That Ganada Sundari Ghosh, wife of Late Mohini Mohan Ghosh, died leaving behind her two aforementioned sons as Surviving legal heirs.

6. That Goutam Kumar Ghosh son of Late Paresh Chandra Ghosh died on 22nd October, 2010 who was a bachelor leaving behind his elder brother Malay Kumar Ghosh who is the surviving legal heir.


