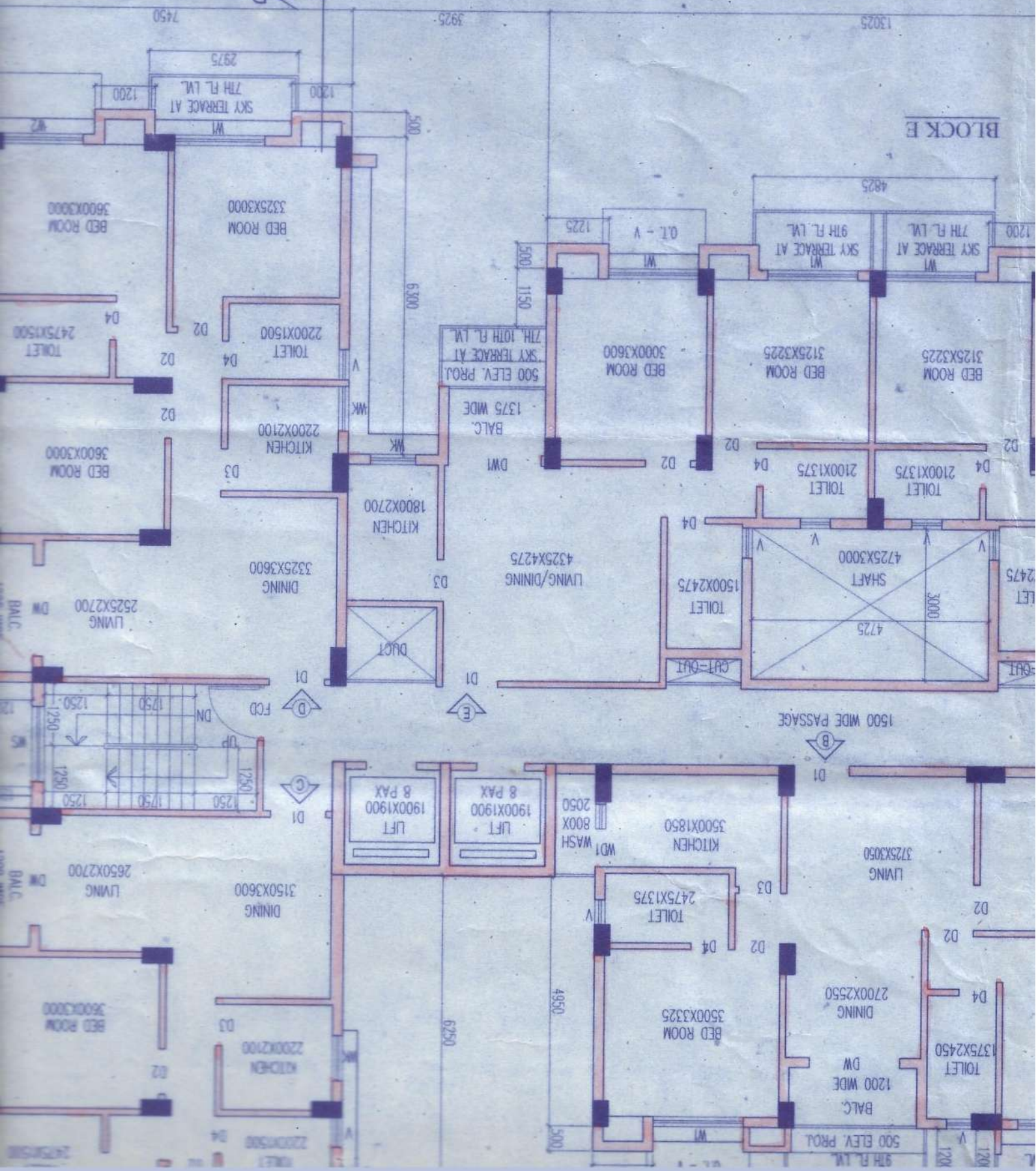
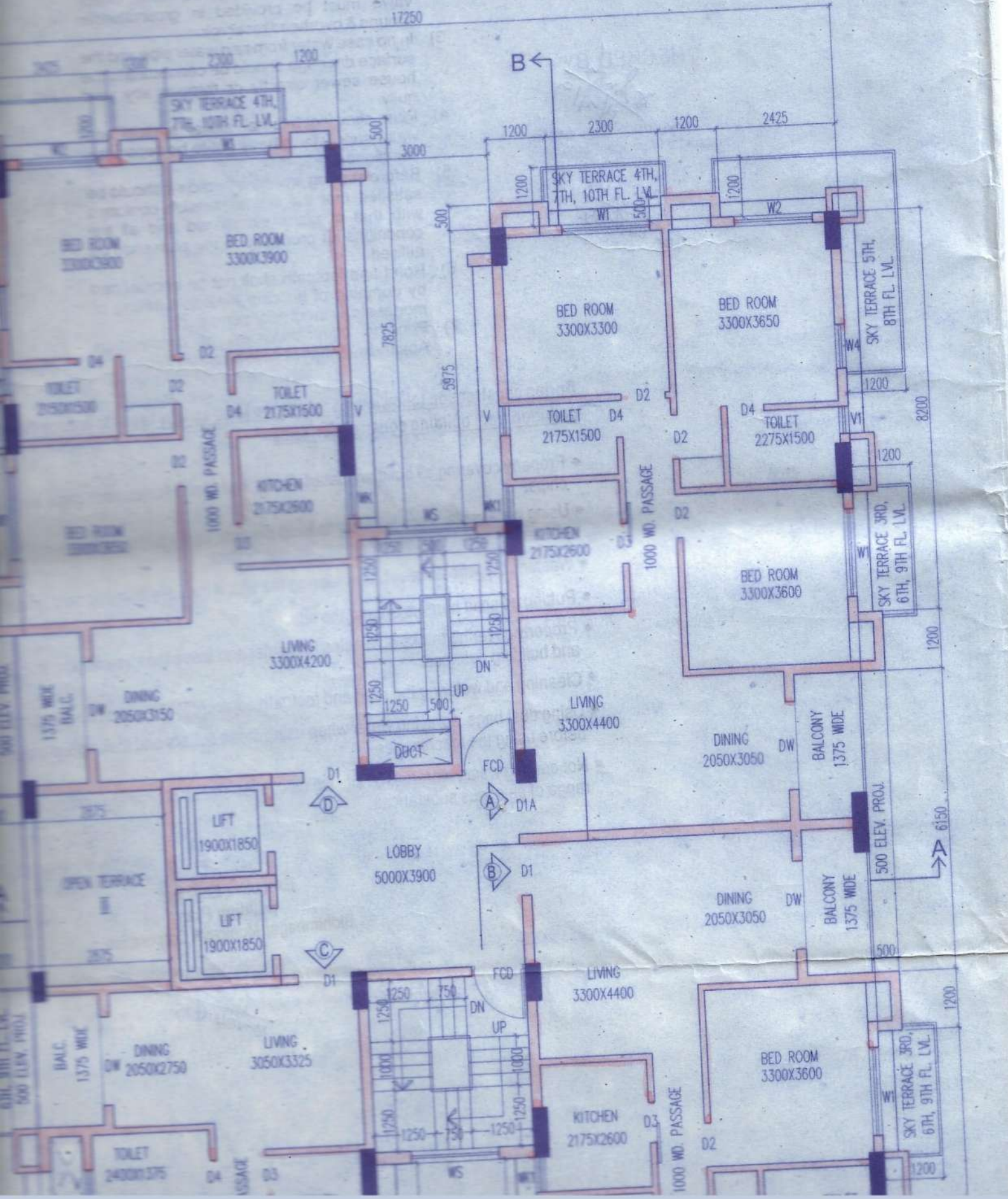


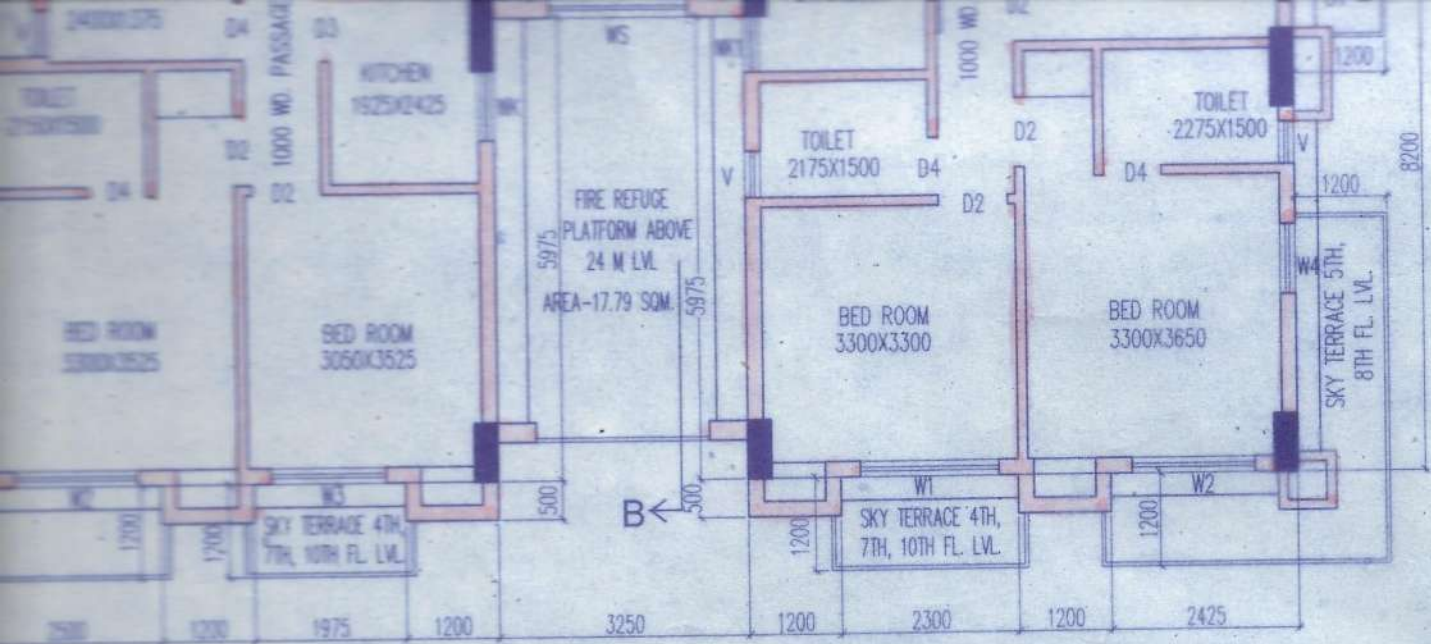
TYPICAL FLOOR PLAN (7TH & 9TH)

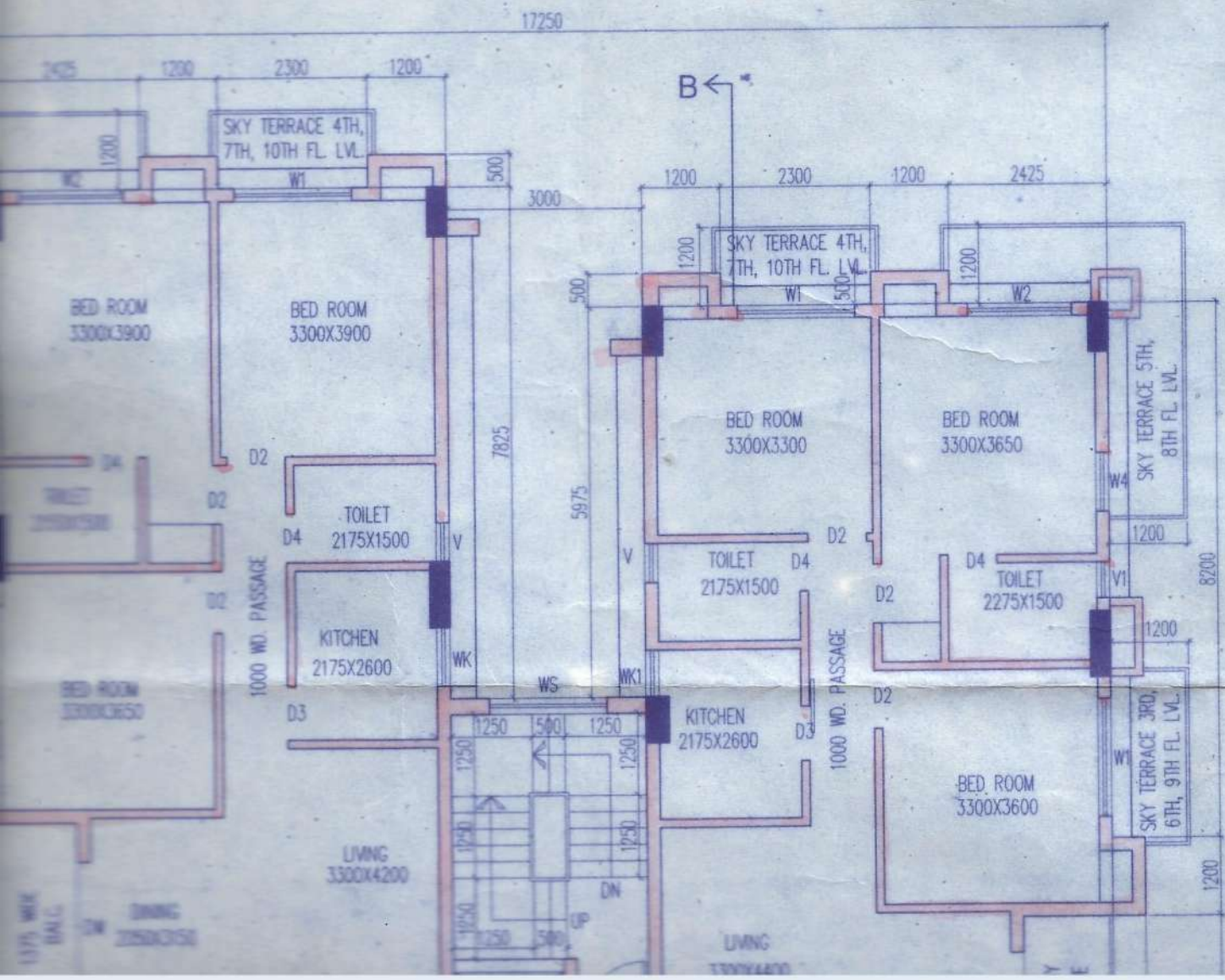


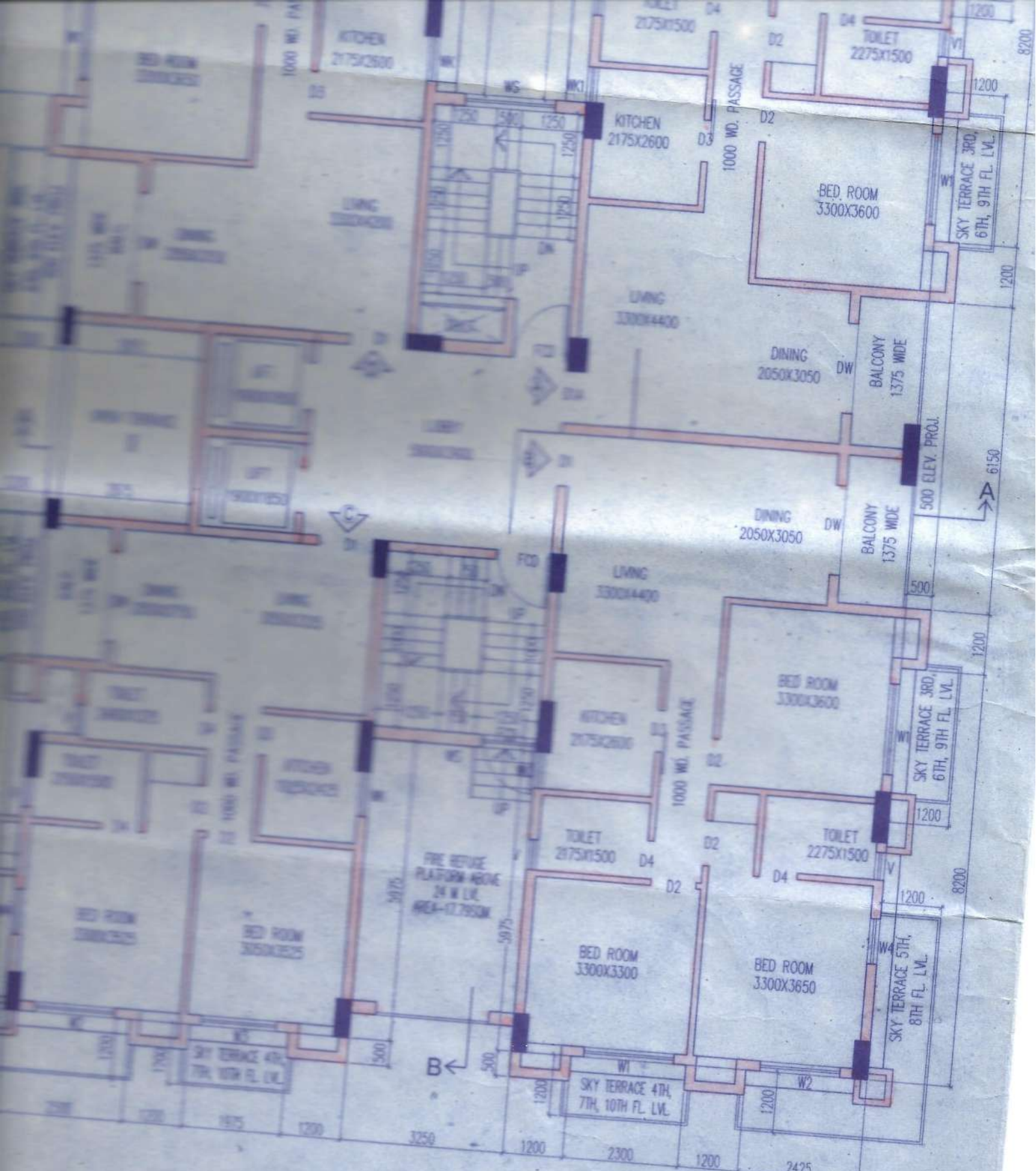

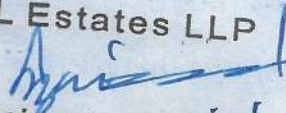
