

The above named plaintiffs and the Defendants compromise  
the suit and Partition the suit property on the Terms and Condition  
mentioned below :-

1. That it is admitted by both the parties that the suit property originally belonged to (i) Biswaswar Roy, (ii) Rameswar Roy and (iii) Bhupaneswar Roy (iv) Manikeswar Roy, all sons of Late Sarada Prasad Roy, having 1/4 th. share in each and they had been in equal possession in the same till their death.
2. That it also admitted by both the parties that Bhupaneswar Roy, was issueless, he expired and on his death his 1/4th share of the ancestral property has been acquired by his three brothers (i) Biswaswar Roy, (since deceased) the predecessor of the plaintiffs and (ii) Rameshwar Roy (since deceased) i.e. the predecessor of the defendant No. 1 and 2 (iii) Manikeswar Roy (since deceased) i.e. predecessor of the defendant No. 3 to 5 equally and thereby the plaintiff No. 1 has acquired 1/6th share, plaintiff No. 2 & 3 jointly have acquired 1/6th. share, defendant No. 1 & 2 jointly

have acquired 1/3rd share and the defendant No. 4 and 5 jointly allotted 1/3rd share within the suit property. Be it stated here the defendant No. 6, Bokul Roy, has got no share within the suit property. Be it stated that in amicable partition the Defendant No. 2 & 3 did not get any share & his share was allotted to the Defendant No. 4 & 5 i.e. her sons the Defendant No. 4 & 5 undertaken to maintain her till her death and after her death they would perform her last rites.

3. That it is fact that in the R.S. record some portion of the suit property has been recorded in the name of Biswaswar Roy, and some properties has been recorded in the name of Raneshwar Roy and Manikeswar Roy, i.e. predecessors of the both the parties and ~~on~~<sup>5/</sup> on that basis L.R. record has also been made in the name of present plaintiffs and the defendants but in fact by virtue of the said R.S. and L.R. Record of the suit property parties did not acquire absolute title therein and it is also admitted by both the parties that the suit property is still in ejmal, no partition has been made as yet <sup>parties</sup> by mates and bounds and they have been facing very inconvenience in possessing the suit property in ejmal hence the parties amicably partition the suit property on by mates and bounds 'A' schedule property is hereby allotted to the plaintiff No. 1, 'B' schedule property is hereby allotted to the plaintiff No. 2 & 3, and the schedule property is hereby allotted to the defendant No. 1 & 2, jointly 'C' and the 'D' schedule property is hereby allotted to the defendant 4 & 5 and it is hereby agreed by and between the parties that henceforth the parties including their legal heirs, legal representatives, successors in interest

in interest including the transferee shall have and shall hold the said property without interruption/obstruction from other parties and the parties are at liberty to record/mutate their respective shares of the suit property so allotted them in the office of B.L. & L.R.O., Asansol, on payment of the proportionate rent payable to the state of West Bengal.

4. That the parties are at liberty to transfer their respective share or any part thereof to any person by way of sale, gift, mortgage, exchange, lease etc. in which other parties have got no objection in the same. Be it stated here the parties after consulting with each other mutually partition and democratise their respective share before such transfer according to their convenience.

5. That is also hereby agreed by and between the parties that besides the suit property if any property is discovered being the joint property of the parties in that circumstances the parties will allot their respective share in the said property also as per the above share.

6. That by virtue of this partition parties shall make the necessary correction of both the K.S. and the L.R. & R.O.R. of the suit property by partition.

6. That the terms and conditions of this partition shall be effective and binding upon both the parties including their legal heirs, legal representatives, successor-in-interest, assignees and the transferee.

It is therefore prayed that your Honour may graciously be pleased to accept the petition for compromise and partition the suit property on the terms and conditions mentioned

therein and pass final decree for partition of the suit property  
and this compromise petition be formed part of the final decree.
