
Subject : Issue of 'NOC' for construction of building at SMC Ward No. 41, Plot No. 152, 153, 152/153(P), Siliguri (WB) by M/s Amartya Commercial Pvt Ltd.

Sir,

I am directed to refer to your application dated 19.02.2013 on the above subject and to say that Air HQ has no objection for construction of 22 meters high residential building project at Plot No. 152, 153, 152/153 (P), near Tarai Lions Eye Hospital, By Lane Sevoke Road, S.M.C Ward No. 41, Siliguri, (WB) by M/s Amartya Commercial Pvt Ltd, subject to the following conditions:-

- a) The vertical extent (highest point) of the buildings proposed at Latitude 26° 44' 30" N and Longitude 88° 26' 30" E shall not exceed 22 meters above ground level/ 154.60 meters above mean sea level. No extension or structure permanent or temporary (eg. Antennas, munties, lift machine room, overhead water tank, cooling towers, sign boards etc) shall be permitted above the cleared height.
 - b) Standard obstruction lightings to be provided by the company. The lights shall be switched 'ON' during night and poor visibility. Provision shall be made for standby power supply to the light to keep them 'ON' during power failure.
 - c) Periodic maintenance of obstruction lightings is to be carried out by the housing society/ owner/ tenants at regular intervals to keep them in visible/serviceable condition.
 - d) A garbage treatment plant shall be installed prior to the construction of buildings for the purpose of avoiding bird activity. The plant shall be shown to the AOC/his nominated representative at AF Stn Bagdogra on installation.
 - e) No light or combination of lights which by reason of its intensity, configuration or colour may cause confusion with aeronautical ground lights of an airport shall be installed at the site at any time during or after the construction of the building.
 - f) The commencement, completion of works inclusive installation of obstruction lights shall be intimated to AOC, AF Stn Bagdogra and CATCO, HQ EAC, Nonglyer, Upper Shillong, Meghalaya - 793009. Failure to render these certificates within the stipulated time may lead to cancellation of NOC.
 - g) The validity of this NOC is five years from the date of issue. If the construction for which NOC has been issued, does not complete within five years of issue or found to be in deviation from original proposal the NOC shall be deemed null and void. It will be the responsibility of the applicant to obtain fresh NOC for the proposal.
 - h) Required security clearance should be obtained through MHA/IB of the foreign Nationals/Indian representative employed/to be employed by the company in India.
2. You are also requested to obtain No Objection from other concerned Government Organization/Agencies as required.


