

<p>2 ----- 17.01.2020</p>	<p>Whereas ,Application No. <b><u>NPR. 00821</u></b> for registration of Real Estate Project has been submitted the applicant with payment on <b><u>11.06.2019</u></b> for registration of the Project to West Bengal Housing Industry Regulatory Authority.</p> <p>And Whereas , the West Bengal Housing Industry Regulatory Authority checked the application and found defective on different points mentioned on the online application remarks column and requested the applicant to resubmit the application .</p> <p>And Whereas , the applicant resubmitted his application online and was found defective on following points as required under Section 4 of the West Bengal Housing Industry Regulation Act, 2017 read with Housing Department's Notification No. 61-HIV/3M-4/18 :</p> <p>PAN Card not authenticated, ITR/Audited Balance Sheet not submitted as per requirement, Encumbrance details not proper, Commencement Letter does not contain commencement date, In Agreement for Sale disclaimer was not found , Number/ type/ carpet area of apartments not listed, Garage declaration , Open Parking Place declaration not as per requirement, Real Estate agent documents &amp; Engineer /Architect documents not submitted as per requirement, Affidavit in Form A not appropriate, Airport Authority clearance /declaration not submitted. .</p> <p>And Whereas ,accordingly an Order sheet was issued on <b><u>15.11.2019</u></b> and the applicant was called for hearing on 29.11.2019 vide Notice for hearing being No.964 (10)- HIRA/2R(Pro)-09/2018 Pt 1 dtd. 15.11.2019 which was sent to the applicant through speed post and Email address provided in the application but the applicant was found absent on the date of hearing and the applicant failed to avail opportunity to resubmit his application.</p> <p>And, Whereas , it is a fact that the application was found defective for not submitting proper documents as required under section 4 of West Bengal Housing Industry Regulation Act, 2017 though opportunity were given several times including hearing .</p> <p>Now therefore , the application No. <b><u>NPR. 00821</u></b> is rejected under section 5(1)(b) of West Bengal Housing Industry Regulation Act, 2017 and forfeiting the application fee.</p>


