
2. This registration is granted subject to the following conditions, namely:-

- (iv) The registration shall be valid for a period of **2.3** years commencing from **18/09/2019** and ending with **31/12/2021** unless renewed by the Housing Industry Regulatory Authority in accordance with section 6 of the Act read with rule 7 of these rules;
